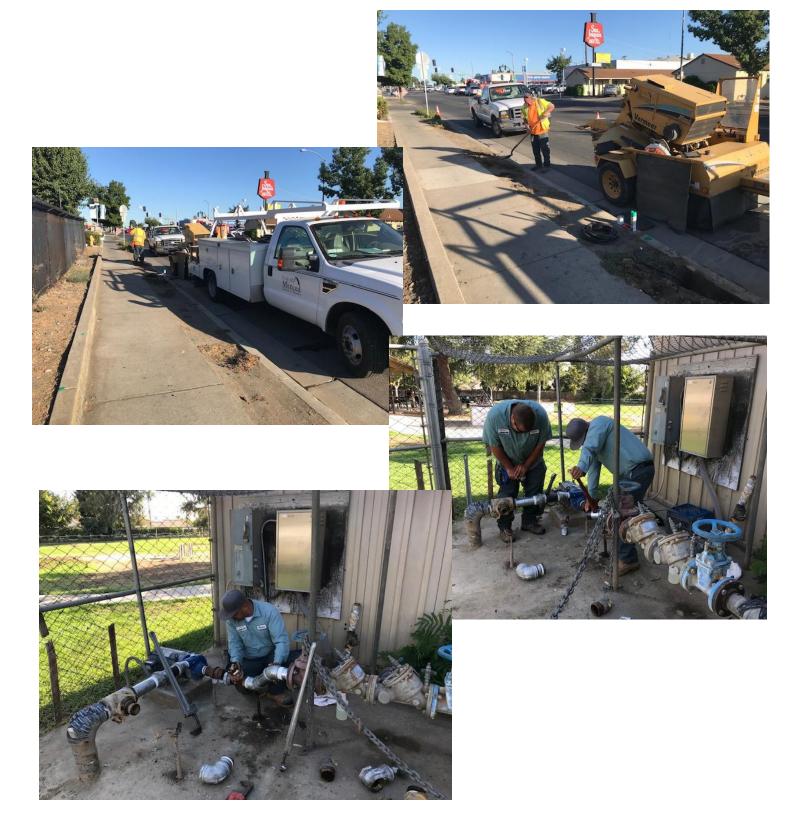
#### **HIGHWAY 99 OVERHAUL**

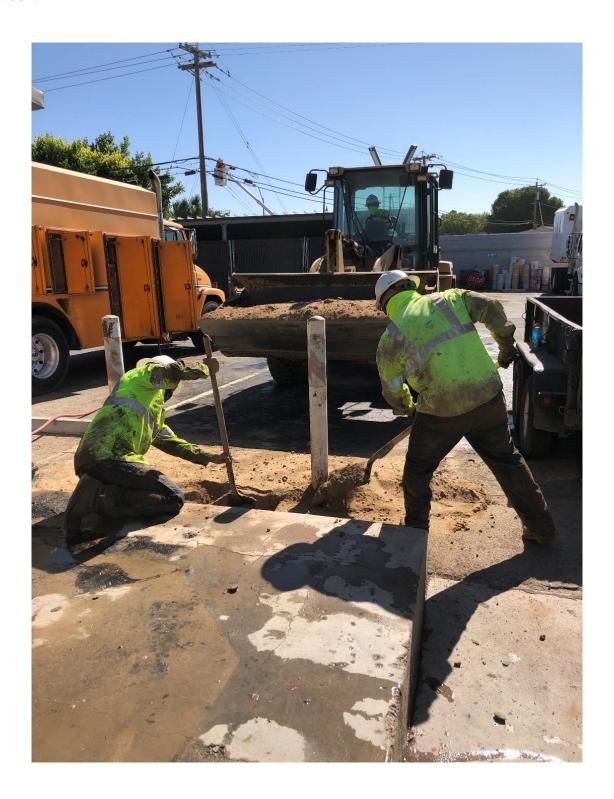
### TREES & PARKS CREWS IN ACTION

Public Works Trees and Parks crews repaired irrigation and grinded stumps along 16th Street, as well as worked on the irrigation system at Rahilly Park this week.



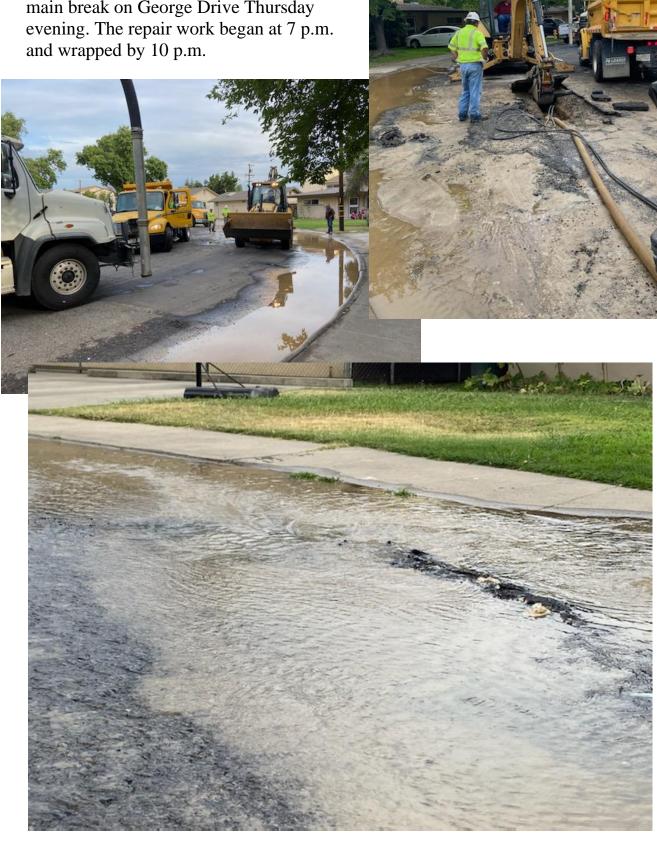
# CREWS REPAIR LEAK AT CORPORATION YARD

# Caltrans Announces More Than \$1.6 Billion for Transportation Projects

SACRAMENTO — The California Transportation Commission (CTC) today allocated more than \$1.6 billion for transportation projects throughout the state, including about \$1.3 billion for State Highway Operation and Protection Program (SHOPP) projects, Caltrans' "fix-it-first" program aimed at preserving the condition of the State Highway System.

"Our maintenance and construction crews remain hard at work improving California's transportation infrastructure," said Caltrans Director Toks Omishakin. "The \$1.6 billion allocated will allow the department to continue with critical repairs and upgrades to roads and highways, and will support thousands of jobs that are essential for our economy."

These were among the local road projects in District 10 that were approved:

- The Fyffe Avenue Grade Separation project in Stockton received \$8 million from the Trade Corridor Enhancement Program. The work will construct a gradeseparated rail crossing, a four-lane overcrossing and realign McCoy Avenue.
- A project that will rehabilitate pavement on State Route 99 from Childs Avenue to Franklin Road in Merced received \$61.3 million. Workers will replace the existing roadway, replace guardrail and upgrade drainage systems.
- A project that will rehabilitate pavement on Interstate 5 at various locations in Stockton received \$36.7 million. By rebuilding the pavement, workers will extend the pavement's service life and improve its ride quality.

 A project that will rehabilitate drainage systems, replace culverts, and create erosion protections in Alpine, Amador and Tuolumne counties received \$5.3 million. A similar project in Alpine County received an additional \$4.3 million.

The CTC also approved more than \$118 million in funds for rail and mass transit projects, including freight, intercity rail and bus services. This allocation expands access to public transportation and helps reduce greenhouse gas emissions and traffic congestion. This investment includes \$77 million for the Trade Corridor Enhancement Program, which is dedicated to projects that enhance the movement of goods along corridors with high freight volume by making improvements to state highways, local roads, freight rail systems, port facilities and truck corridors.

In addition, the CTC approved nearly \$14 million for 17 projects that will improve bicycle and pedestrian overcrossings, repair sidewalks and bike lanes, and provide safer routes to school for children.

Project funding is derived from federal and state gas taxes, including \$1.2 billion from Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017. The state's portion of SB 1 funds are used for the ongoing maintenance and rehabilitation of the State Highway System. By 2027, these funds will enable Caltrans to fix more than 17,000 lane miles of pavement, 500 bridges, 55,000 culverts, and 7,700 traffic operating systems that help reduce highway congestion, such as ramp meters, traffic cameras and electric highway message signs.

#### Inspection Services CI

For the period of July 27<sup>th</sup> through August 9<sup>th</sup>, 2020, there were 23 New Single Family Dwelling Permits Issued.

The running total of New Single Family Dwellings in Plan Review is 597.

#### Multi Family Permits in review:

Gateway Terrace Apartments located at 405 W 12<sup>th</sup> St; 1 office/lounge and 6, 2 story apartments: 2 buildings have 16 units, 3 buildings have 30 units, and 1 building has 4 units for a total of 126 units. Compass Pointe phase II: 128 units in 16, 8-plex buildings, plus a clubhouse.

Merced Station (Yosemite at Lake Apartments) located at 2850 E. Yosemite Ave.; 11 of 15 multi-family apartment permits still pending issuance for buildings 5-15. 5 of those have been issued foundation-only permits (buildings 5-9), as well as the maintenance building. Each building is 27,276 SF, 3-story, 18 units. 72 units total have been issued thus far under 4 of the apartment permits and the master plan is approved.

The Childs & B St. project plan review is approved and the permit is pending issuance. It consists of 5 publicly funded apartment buildings and a community building in an affordable housing development consisting of 119 units on 4 acres located at 1157 B St.

There is also 1 new 2,438 SF duplex in review, located at 345 W. 23<sup>rd</sup> St.

There were 0 multi-family permits issued during this period.

(No change from last report)

There were 0 new construction commercial permits issued during this period.

There were 3 new tenant improvement permits issued during this period; one for the Harvest Cannabis Dispensary located at 863 W. 15<sup>th</sup> St., one for a removal and replacement of a meat case at Grocery Outlet located at 1125 W. Main St., and one for new restrooms at the waste water treatment plant.

There were 3 new commercial submittals during this period; one for the addition of 7- 10'x15' storage units located at 3 W. 23<sup>rd</sup> St., one for a new 4,041 Food-Mart located at 809 S. Coffee St., and one for a 2,264 SF fast food shell building also located at 809 S. Coffee St.

There were 3 new tenant improvement submittals during this period; one for a new Starbucks located at 1665 R St., one for a walkway/upper floor repair at Oak Terrace Apartments located at 1019 Loughborough, and one for a 2,528 SF tenant improvement for doctor's offices locates at 105 W. El Portal Dr. Ste B.

There were 2 CofOs issued for this period; one for the new cosmetics layout at Walmart located at 3055 Loughborough, and one for a tenant improvement for the 9,507 SF Dollar Tree located at 1778 W. Olive Ave.

There were 11 CofOs for Single Family Dwellings during this period.

#### GENERAL INFORMATION

Prior to each regular Commission Meeting, a complete agenda packet is available for review in the Planning Department at 678 West 18th Street, Merced, and on the City's website at <a href="https://www.cityofmerced.org">www.cityofmerced.org</a>. Any documents provided to a majority of the Commissioners after this agenda is posted will be available for public inspection in the Planning Department during normal business hours.

#### THE PLANNING COMMISSION

The citizens of Merced elect the members of the City Council. They in turn appoint seven advisors, the Planning Commission, to make recommendations on planning matters. The Commissioners are civic-minded citizens who serve an average of 35 meetings a year with no pay. Meetings are normally held at 7:00 p.m. on the Wednesday nights following the first and third Mondays of the month, in addition to special meetings as called.

The staff assists the Commission but does not vote. The City Attorney provides legal assistance and assists the Commission on procedural matters; the Planning Director and staff prepare the agenda, provide reports, etc. Other City staff members such as the Civil Engineer also serve as advisors to the Commission.

#### PLANNING COMMISSION MEETINGS

The Commissioners are interested in your views and want to hear them. Information on a proposed action is publicized before it is brought before the Planning Commission. For example, on a proposed zoning action, mailers are sent to all property owners within a 300-foot radius and a notice appears in the legal advertisement section of the Merced Sun-Star. Important pending items will also often be mentioned in pre-meeting references in the local newspaper.

#### **Consent Items**

Items noted as "(CONSENT)" are considered routine and will normally be approved without a staff presentation or discussion by the Planning Commission unless a Commissioner or member of the audience has a question(s) or wishes to make a statement or discuss an item. If so, please approach the microphone at the time the particular item is reached.

#### **Public Hearings**

The Commission will ask those who are for\* or against\*\* a proposal to speak at all <u>public hearings</u>. The sequence of events is:

- Staff report of facts and a recommendation.
- Applicant's statement.
- 3. Proponents\* of the proposal.
- 4. Opponents\*\* of the proposal.
- (5. If necessary, a summary statement or rebuttal from the applicant.)

If you decide to speak, please submit a "Request to Speak" form prior to the start of the public hearing. You will be called up to speak at the appropriate time by the Recording Secretary. Please start by giving your name and city of residence, then tell the Commissioners your concern. We want your views; don't worry about how to say them. If several people have spoken, try not to be repetitious. If there are several in your area with concerns, why not appoint a spokesman. The Commission is particularly interested in the <u>specific reasons</u> you are for or against a proposal because their decision has to be based on specific reasons.

A Commission denial of a request or proposal is final in the case of Conditional Use Permit Applications (unless appealed to City Council within five business days) and Tentative Subdivision Maps (unless appealed to City Council within 10 business days). On many other items, the Commission <u>RECOMMENDS ACTION</u> to the Council. If your item is passed on to the City Council, be sure to follow up by attending the Council hearings and expressing your point of view.

You may also find that the Commission may not get to your item - set for 7:00 p.m. public hearing - until 10:00 p.m. for instance. We regret you having to wait. Experience has shown that setting hearings 1/2 - 1 hour apart is unwise, however. Sometimes matters are withdrawn or are resolved quickly leaving the Commission and public in a position of waiting for an appointed time to arrive.

4.1 Modification to the Pre-annexation Development Agreement for the Absolute-Bright Annexation, initiated by Rick Telegan on behalf of Exposition Properties, LLC, and Leeco, LLC, property owners. The requested modification of Exhibit "D" would remove the requirement that development within the annexation area be done from south to north, thus allowing any of the property owners to develop without being delayed by the development of the other property, and the requested modification of Exhibit "G" would modify Condition #7 of Planning Commission Resolution #2871 removing the requirement that all infrastructure on G Street be completed in one construction project, and not be divided by ownership or tentative maps. The affected property consists of approximately 85 acres, generally located on the east side of G Street, north of Merrill Place (extended). The property has General Plan designations of Low Density Residential (LD), Village Residential (VR), and Open Space/Park Recreation (OS-PK); and is zoned R-1-5 and Residential Planned Development (P-D) #61. \*PUBLIC HEARING\*
