NEW UNEMPLOYMENT FIGURES ANNOUNCED

The unemployment rate in the Merced County was 11.3% in August 2020, down from a revised 14.4% in July 2020, and above the year-ago estimate of 7.2%. This compares with an unadjusted unemployment rate of 11.6% for California and 8.5% for the nation during the same period. The Labor Market Reports for August 2020 are attached for your review.



PACIFIC GAS AND ELECTRIC REGIONAL CENTER EXPANSION

Pacific Gas and Electric was given Site Plan Review approval to construct a 16,800-square-foot metal building for the existing Regional Service Center located at 4155 E. Childs Avenue. The site is located at the University Industrial Park. The Regional Service Center includes management offices, recycling yard, and a garage/warehouse building.

MEET THE NEW PIZZA HUT

Pizza Hut has opened – again. The pizza maker moved across the street from its old location on W. Olive Avenue. The new address is 580 W. Olive Avenue. Some may remember this site as the former Starbucks. The restaurant owners previously announced the restaurant would open on September 17th, but the date was changed to Saturday, September 19, 2020. Hours are 9:30 a.m. to midnight, with the same tasty menu, and it has more than pepperoni on it. Pizza Hut will be heavily focused on take-out, even after the pandemic ends.



AND THE OLD PIZZA HUT SITE?

Dutch Brothers secured Site Plan Review approval for their project to open a second location in Merced at the former Pizza Hut on Olive Avenue. The company has plans to modify the existing 2,410 square-foot building and convert it to a dual drive-through coffee shop.



CHICKEN SHACK SIGN PERMIT

The Chicken Shack will soon be one of Merced's newest eateries. A sign permit has been approved for the location at 560 W. Olive Avenue, next to Deli Delicious. The Chicken Shack was first introduced to the Downtown Subcommittee on February 29, 2020, during their tour of the Fresno Brewery District with Tioga Sequoia Brewing owner Michael Cruz. There are currently three other locations, one in Hanford and two in Fresno.



MERCED FIRE CAPTAIN COLE RETIRING

Despite retiring at the age of 56, he will have no trouble finding ways to pass the time as he and his family have recently sold their house and are moving into their new house in Tennessee.

Methodology:

Monthly city labor force data are derived by multiplying current estimates of county employment and unemployment by the relative employment and unemployment shares (ratios) of each city at the time of the 2014-2018 American Community Survey. Ratios for cities were developed from special tabulations based on ACS employment, unemployment, and population and Census population from the Bureau of Labor Statistics. For smaller cities and CDPs, ratios were calculated from published census data.

Monthly CDP's labor force data are derived by multiplying current estimates of county employment and unemployment by the relative employment and unemployment shares (ratios) of each CDP at the time of the 2014-2018 ACS survey. Ratios for CDPs' were developed from special tabulations based on ACS employment and unemployment from the Bureau of Labor Statistics.

This method assumes that the rates of change in employment and unemployment since the 2014-2018 American Community Survey are exactly the same in each city and CDP as at the

The Consolidated Plan (ConPlan) is a five-year strategic plan developed to determine how these objectives will be met over the next five years within the City of Merced city limits using its CDBG and HOME entitlement grant funds. The 2020-2024 ConPlan strategizes anticipated funding, objectives, and outcome goals for the 2020, 2021, 2022, 2023, and 2024 Program Years. Stockton Diamond Grade Separation Project Wins \$20 Million BUILD Grant from USDOT, Only Rail Project Selected in Nation

STOCKTON, CA – The United States Department of Transportation (USDOT) has awarded a \$20 Million Better Utilizing Investments to Leverage Development (BUILD) grant for the Stockton Diamond Grade Separation Project. It is one of two awards to the State of California during the Fiscal Year (FY) 2020 cycle and the only rail project in the United States to be selected.

The BUILD grant application was prepared by the San Joaquin Regional Rail Commission (SJRRC) and the California Department of Transportation (Caltrans). The \$237 million project would improve mobility through the busiest, most congested at-grade rail junction in California. The construction of a grade separation at this at-grade crossing will make this rail infrastructure more efficient and predictable for both current and future use.

"We greatly appreciate the support of Congressman McNerney, the entire Central Valley Congressional Delegation, USDOT Secretary Elaine Chao, FRA Administrator Ronald Batory, and both the BNSF Railway and Union Pacific Railroad for the Stockton Diamond Grade Separation effort," said Christina Fugazi, Chair of the San Joaquin Regional Rail Commission. "Untangling the Diamond will provide immediate benefits to residents of Stockton, support our plans to expand both the ACE commuter rail service and San Joaquins intercity passenger rail service, and improve freight movements throughout the region. We are extremely proud that this was the only rail project in the nation to win a BUILD award."

The proposed project is a critical element in SJRRC's vision to expand intercity and commuter rail service between the San Joaquin Valley, Sacramento, and the Bay Area. SJRRC is currently in the planning and environmental phase of its nearly \$1 billion "Valley Rail" service expansion program for both the Altamont Corridor Express (ACE) and Amtrak San Joaquins. <u>The Valley Rail Program</u> will implement two new daily round-trips for the Amtrak San Joaquins service and extend the Altamont Corridor Express (ACE) service between Sacramento and Merced. It also supports converting the San Joaquins train and thruway bus network to renewable diesel fuel and is a key component to improving air quality in the region.

"This critical project will improve both passenger and freight rail while pushing economic growth in the San Joaquin Valley," said Caltrans Director Toks Omishakin. "The project will help reduce delays, improve air quality and expand access to the Port of Stockton."

On August 19, 2020, the <u>SJRRC launched the Environmental Review process for the project</u>, in cooperation with the Federal Railroad Administration and the California High Speed Rail Authority. "This project is a critical step in unlocking freight and passenger rail mobility in Northern California. The Stockton Diamond Grade Separation will fix one of the most congested rail corridors, enhance safety, reduce emissions and provide faster, more reliable passenger rail options for our riders," said Kevin Sheridan, SJRRC Director of Capital Projects and the Stockton Diamond Grade Separation Project Manager.
