UNEMPLOYMENT RATE DROPS TO 9.3% IN OCTOBER

The unemployment rate in Merced County was 9.3 percent in October 2020, down from a revised 10.3 percent in September 2020, and above the year-ago estimate of 6.0 percent.

This compares with an unadjusted unemployment rate of 9.0 percent for California and 6.6 percent for the nation during the same period. More Labor Market Information is attached.
