CAPTAIN DON KING RETIRES

Captain Don King started his career working as a Patrol Officer in 1994. Over the years he has worked in several specialty units including Detectives, K-9, Traffic, the Crime Scene Response Team, SWAT, as a Field Training Officer and an Arrest and Control



Instructor. He was promoted to Patrol Sergeant in 2007 and later assigned as the Sergeant over the Disruptive Area Response Team (DART). In 2016, he was promoted to Patrol Lieutenant. During his time as a Lieutenant, he had a collateral assignment as the Acting Chief of Police at Merced College. In 2018, he was promoted to Patrol Captain where he served for the remainder of his career. King's favorite assignment was working as the DART Sergeant.

At their meeting of February 17, 2021, the Planning Commission tabled General Plan Amendment #20-02 and Site Utilization Plan Revision #1 to Planned Development #12 for a proposed mini-mart with fuel island, drive-through business, and office/retail building at the request of the applicant to allow additional time to provide an updated traffic study.

The Planning Commission tabled General Plan Amendment #20-01 and Site Utilization Revision #23 to Planned Development #16 for a multi-family housing project on Devonwood Drive at the request of the applicant until a final decision has been made regarding a potential sale of the property.
