MPD WILL ENFORCE ILLEGAL FIREWORKS

Fourth of July is just around the corner. The Merced PD would like to remind everyone about the consequences and dangers of fireworks. Only "safe and sane" fireworks are permitted in the City.

Fireworks such as mortars, roman candles, bottle rockets and firecrackers are illegal to possess in California. Citations will be issued to violators which carry a fine of \$1,000 for the 1st offense, \$1,500 for the 2nd offense, and \$2,000 for subsequent offenses.

The dangers of illegal fireworks include causing a fire, traumatization of pets, noise and pollution for neighbors, trigger PTSD, injury, and death. We urge everyone to be respectful of your neighbors and think before you light.

Congratulations on making history, Officer Henke!




MPD ALL SMILES AT THE MERCADO


LEAK ALERTS WITH EYE ON WATER TO THE RESCUE

Eye On Water is the app that customers can use to monitor their water usage and set leak alerts.

The admin side of Eye On Water is called Beacon. The Water Division monitors for leaks via this technology and alerts homeowners to potential costly leaks on a regular basis.

Yesterday, after receiving a notice left by Water Personnel, Mary Grissom, the customer called Leah Brown, Water Conservation Coordinator, for guidance on how to stop the leak. After researching the volume of the leak, at 43 gallons per hour, and potential causes, the customer decided to turn off the water to just one toilet in the house to see if the leak could be isolated. 24 hours later, it was clear to see the leak had stopped during the noon hour.

This is just one of many examples of how the features of Eye On Water and follow up by the Water Division help customers identify and narrow down the source of water leaks on the customers' side of the meter.

INSPECTION SERVICES BI-WEEKLY REPORT

For the period of May 17th, 2021 through May 30th, 2021, there were 3 New Single-Family Dwelling Permits Issued.

The running total of New Single-Family Dwellings in Plan Review is 247.

Multi Family Permits in review:

Gateway Terrace Apartments located at 405 W 12th St; 1 office/lounge and 6, 2 story apartments: 2 buildings have 16 units, 3 buildings have 30 units, and 1 building has 4 units for a total of 126 units.

Compass Pointe phase II: 128 units in 16, 8-plex buildings, plus a clubhouse.

There is a fire damage repair that is also adding an ADU located at 1740 Shirley St.

There were 0 multi-family permits issued during this period. (No change from last report)

There were 2 new construction commercial permits issued during this period; one for a shell/TI combo for a convenience store located at 782 Carol Ave., and one for a 300 SF pump house for the Merced Station Apartments located at 2980 E. Yosemite Ave.

There were 6 new tenant improvement permits issued during this period; one for the convenience store shell/TI combo listed above, one for an 850 SF e-cart area for Raley's located at 3550 G St., one for a remodel at the Pacific Breeze Motel located at 951 Motel Dr., one for the addition of 4 nut dryers and silos for Zymex Industries located at 168 Hawk Dr., one for an office remodel for Berkshire Hathaway Real Estate located at 2985 G St., and one for a remodel at T-Mobile located at 1372 W. Olive Ave.

There were 0 new commercial submittals during this period.

There was 1 new tenant improvement submittal during this period; for a bathroom remodel at 3185 M St.

There were 4 CofOs issued for this period; one for a façade remodel and relocation of the entrance at 1122 R St., one for the 16,335 SF Mainzer Theater located at 655 W. Main St., one for an electrical service room at 434 W. Main St., and one for the El Capitan Hotel Laundry Building located at 627 W. Main St.

There were 37 CofOs for Single Family Dwellings during this period.

The Draft Project List for the 2021-2026 Five-Year Capital Improvement Program document is provided at Attachment A. Please note that the budget numbers are still being finalized so they are not included.
