### **REDISTRICTING ADVISORY COMMITTEE**

The Redistricting Advisory Committee will review the current City Council election districts for balanced population and ensure they comply with state and federal election laws based on the 2020 Census data. The Committee will consist of a nine (9) member Committee and must be City of Merced residents.

For more information or to apply, visit the City's website at <u>www.cityofmerced.org</u>, navigate to Popular Links on the homepage, click on "Apply for City Board". All Redistricting Advisory Committee meetings are open to the public and encourages public participation.

The City launched a redistricting webpage for residents to learn more about the City's redistricting efforts including how to get involved and access a number of educational resources at www.cityofmerced.org/redistricting.

On the redistricting webpage, residents can learn about opportunities to participate in the process through four public hearings, plus an information session on map-drawing tools. Residents will have access to the following: tentative schedule of hearings, Redistricting Advisory Committee schedule of meetings, and workshop information as dates are determined. The webpage will be updated frequently.

Also, on the webpage, residents will have the opportunity to learn about the redistricting process, watch videos from past meetings, view presentation slides and any other documents relating to the redistricting process, and see frequently asked questions. Residents may subscribe to receive ongoing updates regarding the City of Merced's efforts.

Soon, residents will have the option to use online map-drawing tools to submit their own suggestions to redraw City districts and offer feedback on previously drawn maps.

### FIRE DEPT. CONDUCTS ANNUAL TRAINING

The Fire Department serves as the City of Merced's confined space rescue service for all City departments as well as the community. Every year, and as required by Cal/OSHA, the Department conducts confined space rescue training throughout the City of Merced.

This year, the Department had the opportunity to conduct its annual entry drill within a digester at the Wastewater Treatment Plant. During the entire week, multiple crews were given a scenario portraying an incapacitated treatment plant employee inside the tank. Each group was required to assess the situation and develop a plan. In accordance with Cal/OSHA requirements, each group monitored the atmosphere within the tank for oxygen, hydrogen sulfide, carbon monoxide, and the level of flammability. Once the known hazards were addressed, a plan was formulated to lower a rescue into the tank, bundle the victim, and remove the individual from the tank.

These types of technical rescues must follow strict regulations and can be challenging at times for rescuers. It is important for the Fire Department to train in the areas they serve and the situations they may encounter.

#### **HISTORY 101 – FOURTH OF JULY**

The Fourth of July—also known as Independence Day or July 4th—has been a federal holiday in the United States since 1941, but the tradition of Independence Day celebrations goes back to the 18th century and the American Revolution.

On July 2nd, 1776, the Continental Congress voted in favor of independence, and two days later delegates from the 13 colonies adopted the Declaration of Independence, a historic document drafted by Thomas Jefferson. From 1776 to the present day, July 4th has been celebrated as the birth of American independence, with festivities ranging from fireworks, parades and concerts to more casual family gatherings and barbecues.

The Fourth of July 2021 is on Sunday, July 4, 2021; the federal holiday will be observed on Monday, July 5, 2021.

**For the period of June 14<sup>th</sup>, 2021 through June 27<sup>th</sup>, 2021**, there were **5** New Single-Family Dwelling Permits **Issued**.

The running total of New Single-Family Dwellings in Plan Review is 277.

Multi Family Permits in review:

Gateway Terrace Apartments located at 405 W 12<sup>th</sup> Street; 1 office/lounge and 6, 2 story apartments: 2 buildings have 16 units, 3 buildings have 30 units, and 1 building has 4 units for a total of 126 units.

Compass Pointe – Phase II: 128 units in 16, 8-plex buildings, plus a clubhouse.

There is a fire damage repair that is also adding an ADU located at 1740 Shirley St.

There were 0 multi-family permits issued during this period. (No change from last report)

There were 3 new construction commercial permits issued during this period; all three for the shell/ TI combination permits for the new Arco convenience store, drive through, and car wash located at the 3100 block of N. Hwy 59.

There was 1 new tenant improvement permit issued during this period; to combine a 2,544 SF suite with the adjacent existing offices for a combined space of 6,968 SF at 478 E. Yosemite Ave., Ste D.

There were 0 new commercial submittals during this period.

There were 2 new tenant improvement submittals during this period; one for a 1,934 SF Starbucks located at 360 W 16<sup>th</sup> St. Ste A., and one for a remodel of the 8,991 SF Advanced Auto Parts located at 1207 W. Main St.

There were 0 CofOs issued for this period.

There were 38 CofOs for Single-Family Dwellings during this period.

### MCAG GOVERNING BOARD ELECTS NEW CHAIR AND VICE CHAIR

The MCAG Governing Board has elected Director Lloyd Pareira to serve as the Board Chair for Fiscal Year 2021 - 2022. Director Pareira currently serves as Merced County Supervisor, District 4, and was elected to his second term in 2020. He has lived on his family's farm near the Merced River



most of his life. He earned his bachelor's degree from California Polytechnic State University, San Luis Obispo, in dairy science. While running his farm, Director Pareira has also served as a trustee on the Merced River School Board, the Boards of the Merced County Farm Bureau and Yosemite Church, and as a delegate for Western United Dairyman.



Director Matt Serrato was elected to serve as the Vice-Chair of the MCAG Board for the 2021–2022 year. Prior to being elected Mayor, Director Serratto served on the Merced City Council representing District 5 for four years. Director Serratto graduated with his bachelor's degree from UC

Davis in 2002 and obtained his law degree from UCLA in 2006. Currently, he is a Chief Deputy District Attorney for the Merced County District Attorney's office. As a Councilmember and Mayor, he has also initiated several community cleanup events and fundraisers and looks to continue with similar humanitarian efforts.

### YARTS LIFTS CAPACITY RESTRICTIONS

The Yosemite Area Regional Transportation System (YARTS) Board of Directors has lifted restrictions on the capacity of its buses traveling to and



from Yosemite National Park. The action occurred at a special meeting of the Board on June 14, 2021, and went into effect on June 15, 2021, when the State of California lifted all social distancing requirements.

The buses had been limited to approximately half of their capacity since the inception of the COVID-19 pandemic in order to allow for passengers to distance from each other as well as the driver. The action taken this week allows the service to resume full capacity of up to 49 passengers on each YARTS bus traveling into and out of Yosemite National Park.

The YARTS service runs coach buses to Yosemite National Park from the six surrounding counties of Merced, Mariposa, Mono, Tuolumne, Madera, and Fresno along highways 140, 395, 120 and 41, respectively. Full summer service schedules are currently in effect.

Although capacity limits have been lifted, other protocols prompted by the pandemic remain in place, such as the wearing of face masks while riding YARTS. These regulations are required for public transportation systems by the Federal Transit Administration and are expected to remain in place until September. Reservations to ride YARTS are available as are walk-on tickets on a first come first serve basis. Passengers do not need a day-use pass issued by the National Park Service to ride YARTS into the Park.

### JULY 2021 - UPDATE

Measure V, Merced County's ½ cent transportation sales tax, was passed by Merced County voters with 71% approval in November 2016. In an effort to keep the community informed about this transformative 30 year measure, MCAG will feature monthly updates in this newsletter. You can also visit:

The 30-year Measure, which commenced in April of 2017, allocates 50% of all its revenue to the cities of Merced, Los Banos, Gustine, Atwater, Livingston and Dos Palos, along with the County of Merced, to pay for local transportation projects including roads, bike paths, and sidewalks; 20 percent of these funds must be used on projects that promote alternative modes of transportation. Regional transportation projects located



on both the east and west sides of the county receive 44% of the funding with five percent reserved for public transit purposes. MCAG receives one percent of the monies to administer all fiduciary and reporting requirements.



Over the past four years, local jurisdictions have made progress on several Alternative Modes projects around the county. These projects include safe alternatives to automobile travel, increase the use of active transportation, and improve air quality. The City of Gustine has been hard at work completing several projects throughout the city to enhance the walkability and ADA accessibility of their community.

Their latest \$23,700 project included improving 290 linear feet of a multi-use path along 6th Street and 3rd Avenue around Henry Miller Park. To date, the City of Gustine has spent \$146,600 on several alternative mode projects throughout the city limits to repair and improve sidewalks and other pedestrian amenities.
