# STRIKE TEAM LEADER MANAGES CREWS AT THE DIXIE FIRE

On July 26<sup>th</sup>, the Fire Department deployed Fire Captain Nathan Frankhauser to assist as a Public Information Officer trainee at the Dixie Fire, which is California's largest wildfire and threatening thousands of structures. Last week, the Fire Department deployed a Strike Team Leader to manage fire crews from the following fire departments: City of Fresno, City of Visalia, City of Selma, City of Los Banos, and Merced County.

### Location, Location, Location

On July 22nd at approximately 12:30 a.m., Merced Fire Department's Engines 51 and 53, and Battalion Chief 506 responded to the area of Phelps and Freemark Drive for a reported vegetation fire. Engine 53 arrived and did not locate a fire in the area however, they located the fire near the area of Horizons Ave. and Monaco Drive.

The fire was about one-half mile away, but the drive distance was closer to three miles. Fortunately, the fire was away from structures and infrastructure. The potential for damage was very low.

After an assessment, a plan was developed to extinguish two large and freely burning debris piles. Each pile was approximately 20 feet wide and one was approximately 8 feet tall. The taller pile was a mixture of dried vegetation and dirt. Extinguishment was difficult and time-consuming. Crews worked smarter and not harder utilizing large diameter permanently mounted nozzles referred to ask deck guns to break down the piles. Commitment time was approximately one hour for the two engines.

Fortunately, there were no injuries or damages. One takeaway from this call for community members to provide accurate details of the location of the fire to allow first responders to respond promptly. The cause of the fire is still under investigation.





### PRODUCTIVE AND POSITIVE RELATIONSHIPS

On July 23rd, the City of Merced Fire Department Engines 51 and 54 assisted Merced County Fire Department with a vegetation fire that spread to a trailer and an RV located in a junkyard.

Productive, positive relationships are important. Local resources have the potential to be overwhelmed by large incidents when multiple units are required to mitigate the problem. The City of Merced Fire Department participates in various types of mutual aid to help our neighbors and in return, our neighbors help us when the need arises.

City of Merced Fire Department Engines 51 and 54 were committed for approximately one hour and two hours respectively without report of injury or equipment damage. Quick response by all units kept this fire contained to a relatively small area. The cause of the fire is still under investigation.
