Multi-Family Permits in review:

- Gateway Terrace Apartments located at 405 W 12th St; one office/lounge and six two-story apartments: two buildings have 16 units, three buildings have 30 units, and one building has four units for a total of 126 units.
- Compass Pointe phase II: 128 units in 16, 8-plex buildings, plus a clubhouse.
- A fire damage repair is also adding an ADU located at 1740 Shirley St.
- Gateway Commons Apartments located at 3130 E. Gerard Ave.; one community building, five buildings with 16 units, and five buildings with 24 units for 200 units, plus 31 garage structures.
- The Hub student housing, located at 3486 McKee Rd.; four buildings consisting of 88 apartments plus first-floor mixed-use and offices. Approximately 185,000 SF total. (no change from the last report)

Multi-Family Permits issued:

• There were 0 multi-family permits issued during this period. (no change from the last report)

Commercial Construction Permits issued:

- One new construction commercial permit was issued during this period; for a 2,200 SF Panda Express located at 165 E. Yosemite Ave.
- Three new tenant improvement permits were issued during this period; one for an ice cream shop located at 540 W Olive Ave., one for a produce cooler at Costco located at 1445 R St., and one for a 10,840 SF office located at 439 W 15th St.

Commercial Permits submitted:

- There were 0 new commercial submittals during this period.
- There were two new tenant improvement submittals during this period; one for a 1,348 SF ground floor mercantile occupancy at the Tioga Apartments located at 1719 N St., and one for a live/work unit located at 2125 O St.

<u>Certificates of Occupancy (CofO)</u>

- One CofO was issued for this period; for a 100 SF office addition located at 580 Collins Dr.
- 24 CofOs were issued for Single Family Dwellings.

Economic Development Update

The Office of Economic Development staff are getting ready for two upcoming outreach events. The Site Selectors Guild is holding a meeting in California, and Economic Development Associate Maria Mendoza will be meeting with the country's leading industrial site locators.

It's been two years since the International Council of Shopping Centers has convened in Monterey for their annual Idea Exchange. Deputy City Manager Frank Quintero and Ms. Mendoza will meet with retail representatives, commercial developers, and retail listing agents.
