1. <u>Request #22-001–Requesting a Crosswalk on Canal St. Behind the Post Office Parking</u> Lot (Jasmine Kaur)

(Citizen states carriers must cross the road every day to get to the other parking lot where half of the postal vehicles are parked. They need a crosswalk for their safety.)

Chairperson Beltran states this area is going part of the Quiet Zone area, we do not allow a mid-block cross walk, there will be safety improvements done and ADA requirements which will help facilitate pedestrian traffic and installing a Quiet Zone in that intersection.

2. Request #22-002-Recreational vehicles being parked on the city streets (Wes Unruh)

(Citizen states recreational vehicles are being parked on the city's streets moving them every 72 hrs. to circumvent the code and are causing blite and inviting crime.)

Chairperson Beltran states this item would have to go to City Council if the Traffic Committee decides to recommend it. This would require the municipal code to be updated. Committee members discuss the need of more information before deciding to send this item to the City Council.

3. <u>Request #22-003 – Requesting speed bumps and a streetlight on Carol Ave. (Marvin</u> <u>Romero)</u>

(Citizen states drivers are driving recklessly at high speeds, side swiping neighborhood vehicles, and causing accidents.)

Committee members discuss the request. There is a four way stop there. This is a behavioral issue, in general speed bumps do not slow people down, and it limits emergency response. The City has a project that is going to reconfigure the intersection at Merced Ave. and Motel Dr. We can reconfigure the project to include signage for this intersection.

(Citizen states there appears to be a lack of common knowledge of the 25 mile per hour speed limit in the residential areas among individuals who drive along Bancroft Dr. in front of Elmer Murchie Park (where a school bus stops twice a day 5 days a week.)

Committee members discuss, recommend additional Police enforcement, Engineering needs to review the plans to see what signage was supposed to be put in. MOTION: To have Engineering to review the plans of the subdivision, if the review determines a speed sign should there, approve the modifications.

(Citizen states residents are using St. Tropez Ave. as a speedway/racetrack.)

Committee members discuss there are stop signs, and the amount of traffic accidents at this intersection does not meet the warrants to add an additional stop sign.

(Citizen states cars are driving excessively fast along M St. and his vehicles have been hit twice. He would like speed bumps to be put in before someone gets hurt.)

Committee Members discuss speed bumps, they present challenges for emergency services causing them to slow down. Committee recommends placing a speed trailer and increasing traffic enforcement in the area.

MOTION: To deny the request and refer the location to the Police department for additional traffic enforcement from 7:00 pm to 2:00 am and the use of the speed trailer as the department deems appropriate.
