

Let's Play Ball!

For the fourth year, Junior Giants is back! The Parks & Community Services Department recently registered 476 youth athletes for participate in the program. The program can support 360 players, so 139 of those registered are on a waiting list.

All divisions are in full swing, including T-Ball (youth ages 5 -6), Co-Ed Minor Ball (youth ages 7-9), Minor Softball (youth ages 7-9), Co-Ed Majors (youth ages 10-13), and a new division, Senior League (youth ages, 14-18), which has space available. Forty-five volunteers will support the program. Opportunities are available for additional volunteers.

Junior Giants is a free, non-competitive, co-ed baseball and softball program. The program offers equipment, uniforms, program incentives, and coach training. The eight-week program allows youth to learn fundamental skills of the sport, including the Four Bases of Character Development: Confidence, Integrity, Leadership, and Teamwork. In addition, coaches will integrate education, health, and bullying prevention activities to equip participants with life skills on and off the field.

The Tennis H.I.T.S program is offered at Applegate Park on the Teal Top Hockey Court, Tuesdays and Thursdays, from 9 am-12 pm. The program will include four twoweek sessions.

During past sessions, youth were treated to an invitation from the USTA to attend the Women's Mubadala Silicon Valley Classic held at San Jose State University. City of Merced Fire Department - History repeats itself.

On April 14th, 1873, local businesses and community leaders of the Central Valley community of Merced met to discuss the need to establish a fire department on the heels of a large fire that devastated the nearby town of Snelling.

Fast forward 150 years to the day and the hour, the Merced Fire Department (MFD) met with the local business and community leaders to discuss the department's future. Chief Derek Parker established a working group to develop the MFD Strategic Planning Committee (MFD SPC) to set the department's strategy for the next 150 years.

Nearly 40 community members and department personnel participated in the first of six meetings to discuss and set rules of engagement for the MFD SPC.

The Committee will hold five additional planning meetings at each fire station to assist with strategy development. In addition, the Merced Fire Department invites the public to attend an open house at each station where they can take a tour and talk with department personnel before the start of each meeting. The Strategic Planning Committee will present the final document on November 3, 2023. This date is significant for the Merced Fire Department; it is the first day the department was available for service 150 years ago.

- There were 0 new construction commercial permits issued during this period.
- There were 5 new tenant improvement permits issued during this period; one for a 1,500 SF ASIP Coffee located at 3562 G St., one for a 2,887 SF 1st floor remodel located at 87 W Alexander Ave, one for a 7,842 SF banquet hall remodel located at 443 W 18th St, one for a 3,112 F restaurant located at 125 E. Yosemite Ave Ste A, and one for repairs at 2200 Cooper Ave.

Commercial & Industrial permits submitted:

- There was 1 new construction commercial permit submitted during this period; for a 6,678 SF preschool located at 3670 G St.
- There were 2 new tenant improvement permits submitted during this period; one for a 19,172 SF AutoZone located at 1158 W. Main St, and one for a 6,933 SF remodel for a cannabis facility located at 1785 Ashby Rd.

Commercial & Industrial Certificates of Occupancy (CofOs)
