N-2 DESCRIPTION OF THE WORK: The work to be performed includes, but is not limited to, remove of existing sidewalk, curb & gutter, asphalt concrete, 30" tree, contractor to install new sidewalk, new curb and gutter paint new curb red and new asphalt concrete.
