- The City Council subcommittee will review proposals and determine funding amounts for each selected applicant.
- Proposals are due by 5 p.m. on Thursday, June 27<sup>th</sup>.
- Our mailing address is listed in the RFP.
- Nonprofit organizations must have a 501c3 status or a fiscal agent who can provide a 501c3 status for the project.
- Nonprofit organization must be based in the city of Merced.
- If you are representing an organization that has been awarded funding in prior years, you should consider this application or submission as a new project.
- The review committee will not have or rely on prior year RFP responses to review and compare.
- Please use the submission requirements as a guide:
  - Introductory letter
    - Use bullet points to identify sections.
      - Organization's name, primary contact, mailing address, physical address, phone number, and email address.
      - Mission, goals, and objectives
      - Address an understanding of the requested service.
        - For example, if your organization provides equineassisted therapy to treat anxiety, ADAH, eating disorders, depression, list your mission, your program goals, and objectives.
  - Staff experience
    - List staff members who will operate the grant (if applicable). Tell the committee who they are and what they will accomplish.
  - Scope of Services
    - The RFP includes a "Scope of Services" work plan B
  - Program Budget
    - The RFP includes a "Program or Project Budget" worksheet C
  - Organizational Operating Budget use worksheet D
- References
  - Minimum of three references from an established organization (please refer to the RFP for more details)
- Non-profit designation and locality
  - IRS Determination Letter
  - CA DOJ Registry of Charities https://rct.doj.ca.gov/Verification/Web/Search.aspx?facility=Y

This is a reimbursable grant. Organizations are responsible for submitting detailed expense reports with corresponding receipts, on a quarterly basis.

- In years past, it has been \$50,000 split up between many organizations leaving about \$5000 per grantee. Is this the case this year as well?
  - The allocation of awards is at the discretion of the committee.
  - The determination is based on the quality and comprehensiveness of the proposal as outlined in the RFP.
- Is 501(c)4 eligible? Under review by the City Attorney 6/12
- Can we use certificates from the State Assembly or State Senate as a reference letter?
  - Yes.
