Single Family Dwelling (SFD) permits:

- SFD Permits Issued: 4
- SFD Permits in Plan Review: **131**
- SFD Certificates of Occupancy: 9

Multi-Family Dwelling (MFD) permits in review:

- Affordable housing located at 3015 Park Ave.: 57,812 SF 3 story new construction, including a 2,744 SF community building. The project will provide 65 1 bedroom, 1-bathroom units and a single 2-bedroom, 1 bathroom unit.
- Two 1,336 SF duplexes located at 103 and 107 R St.
- A 4,624 SF 4-plex located at 1125 H St.
- Emerald Village: 228 units in 18 buildings totaling 142,416 SF of living space, plus a 1,736 SF clubhouse located at 3622 N Hwy 59.
- A 2,680 SF 2 story 4-plex and a 4,020 SF 2 story 6-unit apartment both located at 40 & 30 W 13th St.
- Bella Vista Apartments: 108 units in 5 buildings totaling 135,100 SF of living space, plus a 8,000 SF clubhouse located in the 1800 block of Parsons Ave. (No change since last report)

MFD permits issued:

• There were 0 multi-family dwelling permits issued during this period. (No change since last report)

Commercial & Industrial permits issued:

- There was 1 new construction commercial permit issued during this period; for a 3,800 SF convenience store shell located at 1480 W 16th St.
- There was 1 new tenant improvement permit issued during this period; for the 3,800 SF interior tenant improvements for the convenience store shell listed above, located at 1480 W 16th St.

Commercial & Industrial permits submitted:

- There was 1 new construction commercial permit submitted during this period; for a 3,000 SF addition and flood wall at 2779 N Hwy 59.
- There were 3 new tenant improvement permits submitted during this period; one for interior renovations at the site listed above- 2779 N Hwy 59, one for interior improvements located at 79 W Alexander Ave., and one for interior, exterior, and parking lot lighting upgrades located at 3876 E Childs Ave.

Commercial & Industrial Certificates of Occupancy (CofOs)

• There were 3 commercial, industrial, and multi-family apartment CofOs issued for this period; one for a 1,000 SF tenant improvement for El Portal Cancer Center located at 3303 M St., one for a 2,174 SF urgent care located at 3080 M St., and one for an office split at 3185 M St.
