Merced City Fire Joins the Fight Against Southern California Wildfires

Merced City Fire is proud to play a vital role in supporting our neighboring communities during times of need. This week, the department deployed one Type Three engine, one Type Six engine, one Rescue Task Force Team Member, and a Strike Team Leader, totaling eight skilled personnel, to assist with the Palisades and Eaton Fires. These wildfires underscore the vital role of coordinated mutual aid among fire agencies.

This week also brought a special moment for Captain Akers, who crossed paths with his son, Mason, during their firefighting efforts. Mason, a firefighter with CAL FIRE Tuolumne-Calaveras Unit, and Captain Akers are working opposite shifts on the Palisades Fire but had a brief chance to reconnect between assignments. This highlights the generational commitment of the Akers family to serving and protecting our communities.

Reflecting on this family legacy, we are reminded of a 2008 photo featuring Captain Akers—then a young firefighter—working alongside his father, Chief Akers, during the Telegraph Fire. Their continued service is a symbol of the dedication passed from one generation to the next.

NEW RECTANGULAR RAPID FLASHING BEACONS AT E GERARD & STARLIGHT AVE



The City of Merced has installed Rectangular Rapid Flashing Beacons (RRFBs) at the crosswalk on East Gerard & Starlight Avenue to improve safety for both pedestrians and drivers.

These beacons increase pedestrian visibility, especially in low-light conditions, by flashing brightly when activated. This alerts drivers to the presence of pedestrians, encouraging them to slow down and yield. The addition of RRFBs promotes safer crossing, improves compliance with traffic laws, and provides a cost-effective solution to enhance overall safety at this busy intersection.

The upgrade helps create a more pedestrian-friendly environment, boosting both safety and confidence for walkers in the area.

- Bella Vista Apartments: 108 units in 5 buildings totaling 135,100 SF of living space, plus a 8,000 SF clubhouse located in the 1800 block of Parsons Ave.

All public records relating to an open session item that are distributed to a majority of the Commission will be available for public inspection at the Planning Division Office during regular business hours. The Planning Commission also serves as the Board of Zoning Adjustment and the Design Review/Historic Preservation Commission. Assisted hearing devices are available for meetings held in the Council Chamber.

PUBLIC COMMENT: OBTAIN SPEAKER CARD FROM THE CLERK

Members of the audience who wish to address the Planning Commission are requested to complete a speaker card available at the podium against the right-hand side of the Council Chamber. Please submit the completed card to the Clerk before the item is called, preferably before the meeting begins. Speakers will be called up, 3 to 5 at a time, in the order in which the forms are received. Please use the microphone and state your name and city of residence for the record. For permits, licenses, and other entitlements, the applicant will be allowed 15 minutes (including rebuttal), the appellant/leader of the opposition will be allowed 15 minutes (including rebuttal), and all other speakers shall have 3 minutes each, unless the number of speakers is over 10, which in that case, comments shall be limited to 2 minutes each. For all other issues, for 3 or less speakers, 3 minutes each and for over 10 speakers, 2 A timer clock is located above the City Council dais minutes each shall be allotted. illuminating the remaining time. Once the buzzer sounds, please be courteous and conclude your remarks.

E.1 25-030 SUBJECT: Vesting Tentative Subdivision Map #1334, initiated by Stonefield Homes Inc., property owner. This application involves a request to subdivide approximately 9.9 acres of land into forty-eight (48), residential lots ranging in size from 6,000 square feet to 14,995 square feet. This property is generally located at the southwest corner of Campus Parkway and East Childs Avenue and has a General Plan designation of High to Medium Density Residential (HMD) and a Zoning designation of Medium Density Residential (R-3-2). **PUBLIC HEARING** ACTION: Approve/Disapprove/Modify 1) Environmental Review #24-39 (CEQA Section 15162 Findings) 2) Vesting Tentative Subdivision Map #1334

SUMMARY

The applicant is proposing a tentative map for forty-eight (48) single-family residential lots, south of East Childs Avenue, west of Campus Parkway (Attachment B). The proposed subdivision would subdivide approximately 9.9 acres of land into forty-eight (48) residential single-family lots ranging in size from 6,000 square feet to 14,995 square feet, with no lot being smaller than 6,000 square feet. Planning staff, along with other City staff, have reviewed the project and recommend approval subject to conditions.

RECOMMENDATION

Planning staff recommends that the Planning Commission approve Environmental Review #24-39 (CEQA Section 15162 Findings) and Vesting Tentative Subdivision Map #1334 (including the adoption of the Draft Resolution) subject to the conditions in Exhibit A and the findings/considerations in Exhibit B of Draft Resolution #4147 at Attachment A.
