SECTION 10.32.056, "PASSENGER LOADING ZONES- PERMANENT" AND SECTION 10.32.100, "BUS ZONES- LOCATION" OF THE MERCED MUNICIPAL CODE

THE CITY COUNCIL OF THE CITY OF MERCED DOES ORDAIN AS FOLLOWS:

SECTION 1. AMENDMENT TO CODE. Section 10.28.235, "Motorcycle parking", of the Merced Municipal Code is hereby amended by **adding** the following portions of the following street:

SECTION 6. AMENDMENT TO CODE. Section 10.32.100, "Bus zones-Location", of the Merced Municipal Code is hereby amended by **adding** the following portions of the following street:

On the easterly curb line of T	Beginning at a point 225 feet north of the
Street	curb return at 4 th Street, thence north for a
	distance of 300 feet.

SECTION 7. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 8. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any

competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 9. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.
