

ORDINANCE NO. 2567

AN ORDINANCE OF THE CITY COUNCIL OF
THE CITY OF MERCED, CALIFORNIA,
AMENDING SECTION 10.28.235, "MOTORCYCLE
PARKING", SECTION 10.28.330, "THIRTY-
MINUTE PARKING ZONES- NINE A.M. TO FIVE
P.M." SECTION 10.32.056, "PASSENGER
LOADING ZONES- PERMANENT" AND SECTION
10.32.100, "BUS ZONES- LOCATION" OF THE
MERCED MUNICIPAL CODE

THE CITY COUNCIL OF THE CITY OF MERCED DOES ORDAIN
AS FOLLOWS:

SECTION 1. AMENDMENT TO CODE. Section 10.28.235,
"Motorcycle parking", of the Merced Municipal Code is hereby amended by
adding the following portions of the following street:

Street:

West side of N Street

Section:

Northwest corner of N Street and Main
Street. Beginning at the curb return on N
Street then southeasterly along the curve
14.00 feet towards Main Street.

SECTION 2. AMENDMENT TO CODE. Section 10.28.330, "Thirty-
minute parking zones- nine a.m. to five p.m.", of the Merced Municipal Code is
hereby amended by **adding** the following portions of the following street:

Street:

West side of N Street

Section:

Northwest corner of N Street and Main
Street. Beginning at the second parking
space being 14.00 feet northwesterly from
the curb return on N Street then northerly
28.00 feet towards 18th Street.

SECTION 3. AMENDMENT TO CODE. Section 10.32.056, "Passenger
loading zones- Permanent", of the Merced Municipal Code is hereby amended by
deleting the following portions of the following street:

Street:

West side of N Street

Section:

Beginning at 41 feet north of the north line of Main Street, thence northerly 42 feet.

SECTION 4. AMENDMENT TO CODE. Section 10.32.056, "Passenger loading zones- Permanent", of the Merced Municipal Code is hereby amended by **adding** the following portions of the following street:

Street:

West side of N Street

Section:

Northwest corner of N Street and Main Street. Beginning at the second parking space being 14.00 feet northwesterly from the curb return on N Street then northerly 14.00 feet towards 18th Street.

SECTION 5. AMENDMENT TO CODE. Section 10.32.100, "Bus zones- Location", of the Merced Municipal Code is hereby amended by **deleting** the following portions of the following street:

Street:

On the easterly curb line of T Street

Section:

Beginning at a point six (6) feet south of the centerline of West 5th Street, thence south a distance of two hundred forty (240) feet.

SECTION 6. AMENDMENT TO CODE. Section 10.32.100, "Bus zones- Location", of the Merced Municipal Code is hereby amended by **adding** the following portions of the following street:

Street:

On the easterly curb line of T Street

Section:

Beginning at a point 225 feet north of the curb return at 4th Street, thence north for a distance of 300 feet.

SECTION 7. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 8. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any

competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 9. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.

The foregoing Ordinance was introduced at a regular meeting of the City Council of the City of Merced on the 19th day of August, 2024, and was passed and adopted at a regular meeting of said City Council held on the 3rd day of September, 2024, by the following called vote:
