A. LUS TSHAJ TAWM RAU PEJ XEEM: Nroog Merced yuav ncuab lub sijhawm rau pej xeem los tshuaj xyuas thiab tawm tswv yim txog daim Ntawv Qhia Txog Kev Siv Nyiaj Txiag Tebchaws (HUD) rau xyoo 2025-2029 thiab lub Phiaj Ua Haujlwm rau xyoo 2025. Daim ntawv tshaj tawm yuav pib luam tawm rau hnuv tim 1/31/2025 hauv *Merced Sun Star* thiab 2/6/2025 hauv *Merced County Times*, thiab tau teeb tsa lub sijhawm tshuaj xyuas los ntawm Lub Ob Hlis 19 txog Lub Peb Hlis 20, 2025. Vim muaj kev hloov pauv rau cov ntaub ntawv uas twb tau tshaj tawm lawm, lub sijhawm ntsuam xyuas thiaj yuav tsum tau txuas ntxiv. Tsis tas li ntawd, Nroog tseem tos kev tshaj tawm los ntawm HUD txog cov nyiaj pab txhua xyoo, uas yuav tuaj txog hauv nruab nrab ntawm lub Tsib Hlis 2025 lossis tom qab ntawd. Ib qho Lus Sib Hais rau Pej Xeem kawg yuav raug teem tom qab HUD tshaj tawm cov nyiaj pab thiab yuav tau tshaj tawm ntxiv.
