4. **<u>ITEMS</u>**

4.1 Conditional Use Permit #1219, initiated by Madira Land Convenience Store on behalf of Olivewood Shopping Center, LLC, property owner. This application involves a request to sell beer and wine for off-site consumption at Madira Land Convenience Store, generally located on the south side of Olive Avenue, approximately 400 feet east of Austin Avenue (at 1340 W. Olive Ave., Ste. #102), within Planned Development (P-D) #16 with a Regional/Community Commercial (RC) General Plan designation.

Planner MENDOZA-GONZALEZ reviewed the report. He noted a memo from staff modifying Condition # 17, which was provided to the Commission prior to the meeting. For further information, refer to Staff Report #17-13.

Chairperson DYLINA asked to add a requirement to Condition #21 upon agreement of the Commission that would require "tamper-proof" external trash receptacles to be used.

Chairperson DYLINA also urged staff to provide a more comprehensive police incident report, as the dots used did not provide the number of incidents at each address for the Commission to consider. Commissioner SMITH suggested adding statistics of certain incidences beside the dots that represent those incidences.

Planner MENDOZA-GONZALEZ returned that staff would consult the GIS Technician at the Merced Police Department and attempt to design a color-coded incident map the next time a map is needed for a project.

- "17. No single-serving containers shall be sold separately unless authorized by the City of Merced Police Department. All singleserving beer and wine containers shall be sold as part of a pack or carton."
- "21. A permanent, tamper-proof, outdoor trash receptacles shall be installed near the main entrance to the convenience market."

4.2 <u>Conditional Use Permit #1220, initiated by All Pro Bail Bonds,</u> <u>applicant for Paul and Socorro Gonzales, Trustees, property</u> <u>owners. This application involves a request to relocate an existing</u> <u>bail bond company (All Pro Bail Bonds) from 611 W. Main Street</u> <u>to 735 W. 22nd Street, generally located on the north side of W.</u> <u>22nd Street, approximately 200 feet west of N Street, within an</u> <u>Office Commercial (C-O) Zone.</u>

M/S PADILLA-ALSHAMI**, to adopt a Categorical Exemption regarding Environmental Review #17-11, and approve Conditional Use Permit #1220, subject to the Findings and nine (9) Conditions set forth in Staff Report #17-15:

4.3 Zoning Ordinance Amendment #17-01, initiated by the City of Merced. This application involves changes to the Merced Zoning Ordinance (Title 20 of the Merced Municipal Code) which would replace Merced Municipal Code Section 20.44.170 ("Medical Marijuana and Cultivation") with a new Section 20.44.170 ("Regulation of Commercial Cannabis Activities -Commercial Cannabis Business Permit Required"); amend Section 20.10.020 and Table 20.10-1 ("Commercial Zoning Districts"); amend Section 20.12.020 and Table 20.12-1 ("Industrial Zoning Districts"); and add Land Use Table 20.44-1 to regulate all commercial cannabis activities and cultivation for personal use in the City of Merced. In general, the regulations would allow Commercial Cannabis Businesses, including cultivation, distribution, manufacturing, deliveries, and dispensaries/retail sales, in certain zones with a Commercial Cannabis Business Permit.

Development Services Director McBRIDE addressed the Commission and explained the reason for the meeting. Mr. McBRIDE then addressed the members of the public and gave an overview of the timeline in place for the Draft Ordinance. > and the consultants are present to answer questions regarding the draft ordinance from the Commission. In closing, Mr. McBRIDE addressed City staff and the Consultants of SCI and acknowledged the hard work involved in bringing the Draft Ordinance together.

> Planning Manager ESPINOSA reviewed the report on this item. For further information, refer to Staff Report #17-14.

Chairperson DYLINA inquired about the change in the ordinance from using Health and Safety Code 10590 to the Penal Code for the applicant selection process. He received clarification from Attorney FLORES and deferred to Commissioner COLBY as it was his request to see this modified.

Commissioner COLBY responded that he did not agree with the change made. He expressed concern that it would allow applicants who have been convicted of offenses that include drugs that are more dangerous.

Commissioner CAMPER requested that during the Merit-Based Selection Process, staff inquire of the applicants past experience specifically with running a Dispensary as well as other businesses.

Chairperson DYLINA expressed concern that since medicinal products may be at low demand, dispensaries will not sufficiently stock their inventory with them.

NEIL HALL, SCI Consultants, addressed Chairperson DYLINA's concern. Mr. HALL explained that a majority of the products sold in dispensaries could be interchanged; furthermore, he stated that products mainly used for medicinal uses (that contain CBD over THC) do not degrade as quickly as the THC-based products.

Commissioner PADILLA expressed concern that restricting adult-use dispensaries in the C-O Zone would create problems, financially, for future businesses.

Chairperson DYLINA, in response to Commissioner PADILLA, recollected from the previous meeting that the C-O Zone was mainly designed for an office environment and was not intended for the type of foot traffic that a retail business experiences and deferred to Ms. ESPINOSA for confirmation.

Chairperson DYLINA asked Commissioner COLBY if he wanted to comment further on the use of the Penal Code 667.5 over the Health and Safety Code 11590 in the selection process. Commissioner COLBY elaborated on his concern that the City should be more careful on who would be allowed to apply. He explained that with this new change, there is a risk of allowing applicants who have been convicted of being a part of illicit and illegal drug businesses to operate legally in the City. He suggested that the City re-insert the Health and Safety Code 11590 in addition to Penal Code 667.5 and include a 10 year "wash-out" period for those who have been convicted of crimes listed under the two codes.

Chairperson DYLINA reiterated his concern of the low demand for medicinal products affecting access for patients who are in need of these products. He requested that staff include some form of minimal coverage for that use.

Commissioner PADILLA made a motion to recommend to the City Council adoption of a Categorical Exemption regarding Environmental Planning Commission Minutes Page 7 October 18, 2017

Review #17-10, and approval of Zoning Ordinance Amendment #17-01, modified as follows:

- All four dispensaries must be dual-use (both medicinal and recreational).
- The C-O Zone be open to include adult-use dispensaries.

The motion failed due to lack of a second to his motion.

Commissioner COLBY commented in opposition to Commissioner PADILLA's failed motion. He suggested that neither medicinal, nor recreational dispensaries should be allowed in the C-O zone. He urged that medicinal dispensaries are not really pharmacies due to the general demographic that frequent most dispensaries. He expounded that over the years of his career, he has encountered several cases of fraud and abuse regarding medicinal marijuana users and he stated that this particular issue would not likely change after the adoption of this ordinance. He urged the Commission and staff to keep this in mind as a reason to exclude all dispensaries from the C-O Zone.

Commissioner SMITH expressed a concern regarding the setbacks from City schools and requested that it be increased to 1,000 feet, rather than 600 feet. Commissioner COLBY concurred.

M/S ALSHAMI**-MARTINEZ, to recommend to the City Council adoption of a Categorical Exemption regarding Environmental Review #17-10, and approval of Zoning Ordinance Amendment #17-01, modified as follows:

- No Commercial Cannabis Businesses may be located within a 1,000-foot-radius from a school or within a 600foot-radius of a day care center, recreational center, youth center, library, or public park.
- In addition to those provisions already listed in section 20.44.470 (E)(1)(e), applicants who have been convicted of

felony offenses listed in Health and Safety Code Section 11590 within 10 years from the day they apply shall also be excluded from consideration.
