4. Not more than 50 percent of the intended participants reside outside of the immediate area of the block party.
5. Permission has not been issued within the preceding three months allowing a block party in the same general location and area.
6. The intended location and area is not in such close proximity to hospitals ,churches or businesses as would likely result in the disturbance of these entities
7. No commercial activities are being planned in connection with the block party.
8. Fifty percent of the residents in the area are to be included in the block party and have agreed to have the block party. The sponsor of the block party will be required to submit in writing to the Police Department a written form signed by all persons living within the boundaries of the block party agreeing to the party.

INDEMNITY AGREEMENT

I, the undersigned, realize that all participants of the block party at:

are bound by all applicable laws fully as though the same were inserted herein, and that failure of any participant to comply with any law(s) shall provide cause for immediate revocation of permission to close the public street.

I further realize that it is unlawful for any person to serve, drink, consume or have in their possession any open container of intoxicating beverage in or upon any streets, sidewalks, alleys, parks or parking lots in the City of Merced.

I agree, as sponsor to hold the City of Merced harmless from any and all claims or causes of action for death and or injury to persons, or damage to property, resulting from the intentional or negligent acts errors or omissions of any block party participant, arising out of activities related to the block party.

I further agree to abide by all rules and regulations as outlined in this application.
