A. LUS QHIB

Tebchaws Asmeslivkas Rooj Tsav Xwm Tsev Luam thiab Tsim Vaj Tse Nyob Nto Ntsis Hauv Nroog (U.S. Department of Housing and Urban Development losyog HUD) tseev kom cov nroog uas raug cai (entitlement community yog ib lub zos uas muaj pej xeem coob tshaj 50,000 leej) npaj ib Daim Qauv rau Pej Xeem Tuaj Koom (Citizen Participation Plan*). Daim Qauv no piav qhia txog Lub Nroog Merced (tom qab no hais "Lub Nroog") yuav coj pej xeem tuaj sib koom kev tawm tswv yim, kev khiav dej num thiab kev tshuaj ntsuam xyuas seb tkoj luag hauj lwm Pob Nyiaj Tsim Vaj Tse Nyob Nto Ntsis Hauv Nroog (Community Development Block Grant losyog CDBG) thiab tkoj luag hauj lwm HOME Investment Partnership (HOME) yuav siv nyiaj txiag li cas. Nws qhia Lub Nroog yuav siv tus txheej txheem thiab kev cai dab tsi thaum coj pej xeem tuaj koom Daim Qauv Npaj Tseg rau Tsib Xyoos (Consolidated Plan losyog ConPlan) thiab Daim Qauv Khiav Hauj Lwm (Action Plan).

HUD tseev kom muaj daim qauv ConPlan npaj tseg rau tsib xyoos uas piav txog Lub Nroog yuav ua li cas ntsib tau lub zej zos tkoj kev xav tau Tsev thiab Kev Tsim Vaj Tse Nyob Nto Ntsis Hauv Nroog (Housing and Community Development losyog HCD) kav rau lub sij hawm tsib xyoos. Yuav tsum tsim Daim Qauv Khiav Hauj Lwm (Action Plan) txhua xyoo uas piav seb yuav muab tseem fwv loj, lub lav thiab lub zej zos cov nyiaj txiag coj los siv rau tkoj kev xav tau thiab lub hom phiaj ntawm daim qauv ConPlan txhua tsib xyoos ntawd.

Txoj Kev Coj Pej Xeem Tuaj Koom (Citizen Participation Process) feem ntaw muaj cov kev sib hais (public hearing) txhua xyoo thiab cov kev sib sab laj hauv zej zos/koog tsev kom rov taug xyuas thiab tawm tswv yim rau daim qauv ConPlan, Daim Qauv Khiav Hauj Lwm Txhua Xyoo (Annual Action Plan) thiab Daim Tshuaj Ntsuam Xyuas Raws Xyoo (Consolidated Annual Performance Evaluation Report losyog CAPER). Yuav tsum tshaj tawm qhia pej xeem txog txhua kev sib hais thiab kev sib sab laj raws li HUD, lub lav thiab lub nroog cov txoj kev cai. Hom Phiaj A: Pej Xeem tawm Tswv Yim: Txhua leej txhua tus yuav tsum muaj lub cib fim tuaj koom txoj kev tawm tswv yim rau daim qauv npaj tseg rau tsib xyoos thiab kev txhim kho twg rau daim qauv ConPlan, Annual Action Plan losyog daim CAPER.

COV TXHEEJ TXHEEM:

Daim Qauv ConPlan

- 1) Tsawg kawg nkaus tseev kom muaj ob qho kev sib ntsib hauv zej zog thaum tab tom nrhiav tswv yim los ntawm cov pej xeem rau daim qauv ConPlan. Thaum muaj kev sib ntsib no yuav tsum nug cov pej xeem seb lub zej zog xav tau dab tsi thiab muaj hom phiaj zoo li cas. Pej xeem cov hom phiaj twg uas haum nrog Teb Chaws cov Hom Phiaj (National Objectives) yuav tsum coj los ua tib zoo xav thaum npaj tseg daim qauv ConPlan.
- 2) Thaum npaj tseg daim qauv ConPlan, cov pej xeem nyob hauv tej koog tsev tsim nyog txais CDBG kev pab yuav raug caw tuaj koom tej pwb pab. Tej pwb pab no yuav pab tawm tswv yim hais txog lub zej zog cov hom phiaj rau txoj kev npaj tseg daim qauv ConPlan.
- 3) Thaum sau daim qauv ConPlan thawj zaug lawm tseev kom hu pej xeem tuaj sib koom sib hais tswv yim ob zaug ntxiv. Thaum ntawd luag yuav nthuav piav txog daim ConPlan thiab yuav muab cov lus uas pej xeem hais sau cia.
- 4) Thaum sau daim qauv ConPlan tas lawm, tseev kom muab tso tawm rau pej xeem taug xyuas rau lub caij 30 hnub. Yuav tsum muab daim qauv cia rau hauv Lub Nroog Merced Civic Center ntawm 678 W. 18th Street, thiab/losyog Merced Senior Center, Merced County Library, Merced County Administration Building thiab Lub Nroog daim website rau sawv daws tau pom.

- 5) Ua ntej Nom Tswv Kav Nroog (City Council) yuav pom zoo rau daim qauv ConPlan mas yuav tsum hu pej xeem tuaj sib hais (Public Hearing) tawm tswv yim ntxiv tso.
- 6) Yog hais tias muaj kev txhim kho (amendments) daim qauv ConPlan ces tseev kom rov qab tso tawm rau pej xeem taug xyuas 30 hnub ntxiv. Yuav tsum muab daim qauv cia rau hauv Lub Nroog Merced Civic Center ntawm 678 W. 18th Street, thiab/losyog Merced Senior Center, Merced County Library, Merced County Administration Building thiab Lub Nroog daim website rau sawv daws tau pom.

Daim Qauv Khiav Hauj Lwm (Action Plan)

- 1) Tsawg kawg nkaus tseev kom muaj ob qho kev sib ntsib hauv zej zog thaum tab tom nrhiaiv tswv yim los ntawm cov pej xeem rau Daim Qauv Khiav Hauj Lwm Txhua Xyoo (Annual Action Plan). Thaum muaj kev sib ntsib no yuav tsum nug cov pej xeem seb lub zej zog xav tau dab tsi thiab muaj hom phiaj zoo li cas. Cov txoj luag hauj lwm twg uas haum nrog daim qauv ConPlan thiab Teb Chaws cov Hom Phiaj (National Objectives) yuav tsum coj los ua tib zoo xav thaum npaj tseg Daim Qauv Khiav Hauj Lwm Txhua Xyoo.
- 2) Thaum sau Daim Qauv Khiav Hauj Lwm Txhua Xyoo thawj zaug lawm tseev kom muab tso tawm rau pej xeem taug xyuas rau lub caij 30 hnub. Yuav tsum muab daim qauv cia rau hauv Lub Nroog Merced Civic Center ntawm 678 W. 18th Street, thiab/losyog Merced Senior Center, Merced County Library, Merced County Administration Building thiab Lub Nroog daim website rau sawv daws tau pom.

Daim CAPER

- 1) Ua ntej pib sau daim CAPER, yuav hu pej xeem tuaj sib ntsib tawm tswv yim hais txog cov hauj lwm khiav raws Daim Qauv Khiav Hauj Lwm Txhua Xyoo tsaih no. Kev sib ntsib no yuav muaj thaum lub caij ntuj so kom muaj sij hawm txaus npaj daim CAPER.
- 2) Thaum sau daim CAPER tas lawm, tseev kom tso tawm rau pej xeem taug xyuas thiab tawm tswv yim 15 hnub. Yuav tsum muab daim qauv cia rau hauv Lub Nroog Merced Civic Center

ntawm 678 W. 18th Street, thiab/losyog Merced Senior Center, Merced County Library, Merced County Administration Building thiab Lub Nroog daim website rau sawv daws tau pom.

Hais Txog Txhua Daim Qauv

- 1) Tag nrho txhua kev pej xeem tuaj sib hais thiab sib ntsib yuav tsum yog thaum hmo ntuj, yuav tsum sib ntsib hauv tej qhov chaw uas nyob ncaj kev thiab yooj yim nkag mus los rau cov neeg xiam oob qhab, thiab yuav tsum nyob ncaj kev ntawm qhov chaw caij public transit.
- 2) Lub Nroog yuav tsum muaj neeg txhais lus rau cov neeg uas tsis txawj lus Askiv thiab/losyog cov neeg hnov lus tsis zoo yog hais tias luag thov tsib hnub ua ntej hnub hais plaub ntug ntawd.
- 3) Cov ntawv ceeb toom yuav sau ua lus Askiv, lus Spanish thiab lus Hmoob. Yuav muaj neeg txhais lus tuaj pab nyeem daim qauv ConPlan, Daim Qauv Khiav Hauj Lwm Txhua Xyoo, thiab daim CAPER yog hais tias luag thov kom muaj.
- 4) Txhua lub caij nplooj ntoo zeeg yuav hu pej xeem tuaj sib ntsib thiab hnov txog daim CAPER tsaih no thiab txais lus qhia seb xyoo no Daim Qauv Khiav Hauj Lwm Txhua Xyoo ho mus zoo li cas. Yuav nug cov pej xeemzej zog seb puas muaj lus hais, tawm tswv yim dab tsi, thiab puas muaj lus nug txog HUD cov luag hauj lwm thiab cov nyiaj txiag.

Hom Phiaj B: Qhia Pej Xeem: Yuav tsum faib lus thiab ntaub ntawv txaus rau tag nrho txhua leej txhua tus thiab txhua pab pawg uas thov kom paub txog.

COV TXHEEJ TXHEEM:

- 1) Ua ntej yuav pom zoo rau daim qauv ConPlan losyog Daim Qauv Khiav Hauj Lwm, Lub Nroog yuav tsum qhia rau txhua leej txhua tus thiab txhua pab pawg uas thov seb Lub Nroog xav tias yuav txais nyiaj ntau npaum li cas los ntawm pob nyiaj CDBG, xam rau hauv muaj qhov yuav tau nyiaj pes tsawg pab rau cov neeg muaj nyiaj tsawg kawg (very low income) thiab cov neeg muaj nyiaj tsawg (low income). Tsis tas li ntawd, Lub Nroog yuav tsum qhia seb txoj kev siv cov nyiaj txiag no yuav tsum siv rau tej hauj lwm dab tsi, thiab yuav tsum qhia seb yuav npaj tswv yim dab tsi txo qhov tso neeg tawm ntawm lawv qhov chaw nyob kom tsawg, thiab qhia seb yuav npaj tswv yim dab tsi kom pab tau cov neeg uas raug tso tawm ntawm lawv qhov chaw nyob.
- 2) Lub Nroog yuav tsum qhib kev kom tsim nyog thiab tsis siv sij hawm ntev (reasonable and timely access) rau txhua leej txhua tus thiab txhua pab pawg uas xav paub txog tag nrho cov ntaub ntawv hais txog Lub Nroog daim qauv ConPlan losyog Daim Qauv Khiav Hauj Lwm thiab txog Lub Nroog txoj kev siv nyiaj txiag raws xyoo rau cov luag hauj lwm no.

- 3) Yog leej twg thov kom muaj yuav tsum muaj ib tug neeg txhais lus losyog ib tug neeg lis hauj lwm tuaj pab kom to taub cov lus thiab ntaub ntawv uas muab faib ntawd.

Hom Phiaj C: Ceeb Toom rau Pej Xeem: Lub Nroog yuav tsum tshaj tawm lus ceeb toom txaus rau pej xeem paub ua ntej thaum muaj kev sib ntsib thiab kev sib hais.

COV TXHEEJ TXHEEM:

- 1) Lub Nroog yuav tsum tshaj tawm lus ceeb toom txaus rau txhua leej txhua tus thiab txhua pab pawg uas xav paub txog kom paub ua ntej txog tag nrho cov kev hu pej xeem tuaj sib hais thiab sib ntsib. Yuav tsum sau ntawv ceeb toom txaus hais txog lub ntsiab lus ntawm txoj kev sib hais losyog sib ntsib rau pej xeem paub. Lus ceeb toom no muaj xws li sau rau hauv phau xov xwm *Merced Sun-Star* thiab phau *Merced County Times*, xa tsab ntawv tuaj, xa ntawv ceeb toom mus rau tej neeg thiab tej pab pawg uas xav paub txog, tshaj tawm hauv cov list serve, cov me nyuam phau xov xwm thiab phau ceeb toom hauv tej koog tsev, losyog tshaj tawm hauv xov tooj cua.

Hom Phiaj D: Kev Pab: Lub Nroog yuav tsum faib kev pab (technical assistance) rau txhua leej txhua tus thiab txhua pab pawg uas thov kev pab.

COV TXHEEJ TXHEEM:

- 1) Lub Nroog yuav tsum faib kev pab, haj yam yuav tsum pab cov pab pawg losyog cov tib neeg uas sawv cev ntawm cov neeg muaj nyiaj tsawg kawg losyog cov neeg muaj nyiaj tsawg. Txoj kev pab no yuav tsum yog pab npaj tswv yim thiab sau ntawv thov nyiaj pab khiav tej luag hauj lwm (formula programs) uas muaj nyob hauv daim qauv ConPlan. Lub Nroog yuav tsum txiav txim siab yuav pab tau npaum li cas. Txoj kev pab no muaj raws li nram qab no:
 - Pab sau txhab ntxiv rau cov ntaub ntawv/cov ntawv thov nyiaj
 - Pab piav txog txoj kev xa ntaub ntawv thov nyiaj mus

tuaj sib hais losyog sib ntsib thaum txais tswv yim npaj losyog txhim kho daim qauv ConPlan, Daim Qauv Khiav Hauj Lwm Txhua Xyoo losyog daim CAPER.

- 2) Yuav tsum ua tib zoo xav txog cov lus thiab cov tswv yim, hais tuaj thaum hu pej xeem tuaj sib hais losyog luag xa tuaj thaum lub sij hawm taug xyuas thiab txais tswv yim ntawd los xij. Thaum sau cov ntaub ntawv tas lawm yuav tsum muaj ib feem hauv uas sau tag nrho cov lus luag hais, thiab ntxiv yuav tsum sau qhia seb vim li cas tsis tau txais cov tswv yim twg.
