## **G Street Underpass** *Construction begins in July*

When the G Street undercrossing is completed 18 months from now it will provide a safe, quick route under the Burlington Northern and Santa Fe Railroad tracks.

The \$18 million project is paid for by state and local funding, with some help from the BNSF railroad.

The project will begin in July

and construction will last approximately a year and a half.

While a portion of G Street is closed for construction, please allow extra travel time because traffic on the through streets is expected to be heavier.

## Ask the City: It's not legal to dig in other's trash

Ask the City is an ongoing column answering questions that have been submitted to us by mail, email or phone. Readers can submit their questions to the addresses in the column on the left.

I found someone going through my trash can. I think they were just looking for bottles and cans, but I'm worried someone may steal my identity. What can I do? *Phone call and email* 

"Dumpster diving" has become a cliché for people who haul things out of the trash for their own use, but it is a legitimate concern for several reasons.



Sometimes the people digging through the blue recycling container leave a mess on the ground that the property owner has to clean up.

Sometimes they are taking the CRV bottles and cans in the container, which is illegal.

And sometimes they are going through your containers looking for a credit card

## Think Green

### Be careful what you put in your green and blue

Recycling and composting are good for the planet, and also good for helping us comply with AB 939, a law requiring cities to reduce the amount of stuff that ends up in the dump by turning it into compost or getting it recycled.

City residents have been pretty good about using the three container system, but some need a refresher.

The green container is only for green waste like lawn clippings, small branches and your Christmas tree during the season. IT IS NOT FOR GARBAGE. And don't put any of the green waste in a bag inside the container. That "contaminates" the load because it is assumed to be garbage.



The blue container is for recyclables, such as clean paper, cans and bottles. Due to some changes on the recyclers' end of the chain, we can only take No. 1 and No. 2 plastics. Look at the bottom or side of the

container for a little triangle with the number inside of it. Some of the items that are 1 or 2 plastics are:

Milk jugs, bleach, detergent, household cleaner bottles, shampoo bottles, soft drink, juice and water bottles, peanut butter, salad dressing and vegetable oil containers.

There are some trash and shopping bags that also are No. 2.

Thanks for doing your part to recycle, compost and reduce tonnage in the landfill.
