MAYOR TRAVELS TO WHITE HOUSE



Merced mayor meets at White House to talk about affordable housing barriers

Merced Mayor Mike Murphy on Wednesday met with Housing and Urban Development Secretary Ben Carson as part of a group of elected officials from across the county who gathered at the White House in Washington D.C. to discuss the housing crisis.

Murphy said the bipartisan round-table discussion served as a fact-finding meeting for Carson and leaders of other federal agencies.

"I shared with Secretary Carson and the broader group the challenges we have in terms of the housing market," Murphy said. That included talking about the misuse of well-meaning environmental laws to stop good development and his concerns that building affordable housing can be much more expensive than other housing options.

HANDS-ON SKILLS TESTING

Applicants for the Water Distribution Operator I/II position went through a handson practical skills test this Wednesday at Water Well Site No. 2. Ten applicants participated and were graded on their performance at 5 work stations, including common tool and water part identification, water service meter installation procedures, water main leak repair procedures, vehicle & dump trailer pre-trip and operation course, and excavation & forming for a 1' x 1' concrete pad.

ASSEMBLY HEARING ON HIGH SPEED RAIL

The Assembly Committee on Transportation held an information hearing on High Speed Rail in Fresno on Tues., Nov. 12. Discussion centered on funding for the Valley to Valley connection, ridership, and progress on the construction efforts. Council Member Matt Serratto addressed the Assembly Committee presenting a case on why the Valley to Valley connection should include the City of Merced. Also speaking in support of the Valley to Valley Connection was former Merced College president Dr. Ben Duran.





HIGH SPEED RAIL BOARD MEMBER PEREA VISITS MERCED

Recently appointed High Speed Rail Authority Board Member Henry Perea and HSR Central Valley Project Manager Diana Gomez met with Mayor Mike Murphy, Council Member Matt Serratto, and City staff. Board Member Perea was presented with the background of High Speed Rail in Merced, and the City's desire to relocate the proposed Downtown Station. Following the meeting, Mayor Murphy and Council Member Serratto walked Downtown Merced with Mr. Perea highlighting the current projects under construction and improvements. The tour concluded with a walk-thru at the Merced Transpo Center. The meeting was coordinated by Richard Harmon, Townsend Public Affairs, and included City Manager Steve Carrigan, Assistant City Manager Stephanie Dietz, and Economic Development Director Frank Quintero.



LABOR MARKET INFORMATION – OCTOBER 2019

The unemployment rate in the Merced County was 5.8 percent in October 2019, up from a revised 5.5 percent in September 2019, and below the year-ago estimate of 6.2 percent. This compares with an unadjusted unemployment rate of 3.7 percent for California and 3.3 percent for the nation during the same period. The Labor Market Information reports are attached for your review.

ECONOMIC DEVELOPMENT UPDATE

The Site Plan Review Committee met and approved a site plan for a new Starbuck's drive-through at R Street and W. Main Street. The developer will be following up with staff regarding building permit application and minor changes to the site plan. Economic Development Director Frank Quintero met with the developers of the Campus Parkway Plaza regarding infrastructure improvements and building permit application timing for Phase 1 of the project. Director Quintero also met with representatives from the Gateway Center project. The development team reported that infrastructure improvements are underway at Coffee Street and Campus Parkway (pictured below). An update on the Sears redevelopment project was discussed with the Office of Economic Development staff led by Seritage's developer.
